<u>Remove Original Article IX, Section 19, Rentals</u> <u>"Any lease between an Owner and a lessee shall</u> provide that the terms of the lease shall be subject in all respects to the provisions of this Declaration and the Articles of Incorporation and By-Laws of the Association, and that any failure by the lessee to comply with the terms of such documents shall be in default under the lease. All leases shall be in writing. No home or lot may be leased for a period of less than 90 days. Other than the foregoing there shall be no restrictions on the right of any Owner to lease his Home."

The above paragraph is replaced with Article IX, Section 19, Rentals below:

Section 19, Rentals

Any lease between an Owner and a lessee shall provide that the terms of the lease shall be subject in all respects to the provisions of this Declaration and the Articles of Incorporation and By Laws of the Association, and that any failure by the lessee to comply with the terms of such documents shall be in default under the lease. <u>All leases shall be in writing with a copy provided to the Board</u>. The homeowners must personally reside in that home for a minimum of three (3) years before leasing is permitted. No more than six (6) homes in the Grove & Brooks Bend neighborhoods may be leased at one time. No home or lot may be leased for a period of less than 120 days. Ten (10) current lease owners will be grandfathered until sold by current owner, list of addresses attached as page 3. Other than the foregoing, there shall be no restrictions on the right of any Owner to lease his home.
